Privacy Policy

This Privacy Policy describes the ways in which Personal Information about individuals (“Users”) who use this website (www.fondationipsen.org) may be collected, stored and used by Fondation IPSEN / Fondation de France, 65 quai George Gorse, 92650 Boulogne-Billancourt, France, the data controller.

THIS PRIVACY POLICY MAY PERIODICALLY CHANGE, BE MODIFIED, OR OTHERWISE UPDATED WITHOUT PRIOR NOTIFICATION. However, your Personal Information (as defined below) will always be handled in accordance with the Privacy Policy that was in effect at the time of collection.

1. Personal Information collected:

Fondation IPSEN / Fondation de France may collect Personal Information when you register to become a User, including your name, e-mail address, position, working address. If you wish to receive information from Fondation IPSEN / Fondation de France, these categories of Personal Information are mandatory.

When you register as a User, we clearly label which information is required for registration, and which information is optional and may be given at your discretion.

2. Use of Personal Information:

Your Personal Information will only be processed for the purposes of the legitimate interests pursued by Fondation IPSEN / Fondation de France, namely having a better interaction with you and making your access to science easier.

Your Personal Information will not be sold, shared or otherwise distributed to third parties without your consent, except where we are required to do so because of an applicable law, court order or governmental regulation, or if such disclosure is otherwise necessary in support of any criminal or other legal investigation or proceeding here or abroad.

3. Term of retention of Personal Information

Your Personal Information is processed and kept for no more than three years from the latter: (i) its collection or (ii) the latest contact we have with you.

4. Security

Your Personal Information will be stored on secure servers and maintained strictly confidential. You are responsible for maintaining the secrecy of your unique password and account information.

. Right of access, correction and objection

You have a right of access, correction, deletion, restriction and objection to the use of your Personal Information. In this case, you will be informed about this and your Personal Information will only be retained to meet those purposes.

7. Cookies

This Website uses anonymous analytics, including cookies generated by Google Analytics. Cookies are small data files which are placed on your computer, smartphone or other device. Cookies are stored on the hard disk of your device without any risk of damaging it.

Cookies allow us to collect automatically certain user data during your use of the Website, such as:

- The IP address of the User (this address, which allows access to the Internet, is assigned to the device of the User by the Internet service provider and the information, which changes according to the session of the User, is not directly personally identifiable);
- The date and time of the visit of the User on the Website;
- The operating system of the User's device as well as its browser;
- How the User accesses the Website.

The Website uses several types of cookies:

Strictly necessary cookies: These cookies are essential in order to enable you to move around the Website securely and use its features.

Performance cookies: These cookies collect information analytics about how visitors use the Website, for instance which pages visitors go to most often, and if they get error messages from the Website. This includes analytics cookies generated by Google Analytics.

These types of cookies do not collect information that directly identifies Users, but instead make use of numbers and codes. This information is solely used to administer the Website and improve the User experience. The information is not used to create profiles on Users or to provide targeted advertising. Fondation IPSEN / Fondation de France will not retain the personal data collected (the cookie identifier) for longer than thirteen months.
